1. PROMOTER

2. ACCEPTANCE OF TERMS

- 2.1. By entering this Promotion, you acknowledge that you have read, understood, and agree to be bound by these terms and conditions in their entirety.
- 2.2. These terms and conditions may be varied, amended, or modified at any time at the sole discretion of the Promoter. Any such variations shall take effect immediately upon publication or notification to participants. Participation in this Promotion following any variation shall constitute acceptance of the amended terms and conditions.
- 2.3. These Terms and Conditions will be available via the Plus Fitness website and via a link accessible through the entry form.

3. DEFINITIONS

Eligible Individual means a member of the public aged 18 years or over who submits an Eligible Entry during the Promotion Period.

Ineligible Individual means any current or active member of Plus Fitness at the time of entry; any employee, officer, director, contractor, or agent of the Promoter, Viva Leisure Limited, or any of its related bodies corporate; or any person otherwise directly involved in the administration or conduct of the Promotion.

Eligible Entry means a completed entry submitted by an Eligible Individual via the designated KeepMe lead form in connection with the relevant Plus Fitness activation during the Promotion Period.

Each activation will operate only during the applicable event date and within the operating hours of the Plus Fitness activation area at the relevant venue.

4.2. Upon cessation of the Promotion Period for each event:

- a) no further entries into the Promotion will be accepted for that event; and
- b) the Promoter may, at its discretion, accept any valid entries submitted prior to the close of the activation.

4.3. The Promoter reserves the right to amend the Promotion Period or activation times where reasonably required due to operational, safety, or event-related circumstances.

4.4. The Promoter accepts no liability for any loss, inconvenience, or disappointment suffered by any person as a result of the amendment, suspension, or termination of the Promotion.

5. ENTRY

5.1. Eligible Individuals may enter the Promotion by completing and submitting the designated KeepMe lead form at the Plus Fitness activation at the relevant South Sydney Rabbitohs game during the Promotion Period.

5.2. Each Eligible Individual is permitted a maximum of one (1) entry per activation event.

5.3. Entry into the Promotion is free. No purchase or membership is required to participate.

5.4. Entrants must provide accurate and complete contact details including their name, phone number and email address.

5.5. The Promoter reserves the right to verify the validity of entries and to disqualify any entry that is incomplete, inaccurate, misleading, or not submitted in accordance with these Terms and Conditions.



5.6. The Promoter is not responsible for technical malfunctions, network issues, or other circumstances that may prevent submission of an entry.

6. PRIZE

6.1. The prize pool consists of three (3) Plus Fitness 12-month prepaid memberships providing access to Plus Fitness locations nationwide, with an approximate retail value of AUD \$1,037.40 per membership.

6.2. One (1) prize will be awarded for each activation event conducted during the Promotion Period.

6.3. Each prize is non-transferable and cannot be exchanged for cash or alternative benefits.

6.4. The winner must complete the standard Plus Fitness membership registration process before activating the prize.

6.5. Use of the prize membership is subject to the standard Plus Fitness membership terms and conditions, as amended from time to time, and the rules and policies applicable to the relevant Plus Fitness clubs.

6.6. The prize does not entitle the winner to membership or access to Plus Fitness facilities where the winner would otherwise be ineligible for membership or barred from access under the applicable membership terms and conditions, club rules, or applicable law.

6.7. The winner must comply with all safety procedures, facility rules, and reasonable directions of Plus Fitness staff and franchise operators when using the membership. Failure to comply with these requirements may result in suspension or termination of the membership in accordance with the applicable membership terms and conditions.

- 6.12. If the winner holds an active Plus Fitness membership at the time the prize is awarded, the Promoter may apply the prize by suspending the winner's regular membership fees for the duration of the twelve (12) month prize period.
- 6.13. During the prize period, the winner's existing membership agreement will remain in effect.
- 6.14. At the conclusion of the prize period, the winner's membership will continue in accordance with the existing membership agreement and regular membership fees will resume unless the winner cancels their membership in accordance with the applicable membership terms and conditions.

7. PRIZE DRAW

- 7.3. Each Eligible Individual is permitted to submit a maximum of one (1) entry per activation event during the Promotion Period. The Promoter reserves the right to verify the identity of entrants and determine whether multiple entries have been submitted by the same individual.

7.6. Winners will be notified using the contact details provided in their entry form.

7.7. If a winner cannot be contacted within thirty (30) days of the draw, the Promoter may conduct a redraw to determine an alternative winner.

8.1. - 12.3. Neither party shall be liable for any delay or failure to perform its obligations under these Terms and Conditions due to causes beyond its reasonable control, including but not limited to acts of God, natural disasters, pandemics, labour disputes, cyberattacks, or government actions.
- 12.4. These Terms and Conditions are governed by the laws of the Australian Capital Territory. The parties submit to the exclusive jurisdiction of the courts of the Australian Capital Territory for the resolution of any disputes.
